



## गो फर्स्ट को 16 नए इंजन मिलने की उम्मीद

कई मोर्चों पर बाधाओं का समाना कर रही विमानन कंपनी गो फर्स्ट को एक सरकारी योजना के तहत अतिरिक्त 400 करोड़ रुपये मिले हैं। इसके साथ ही उम्मीद है कि अनेक वाले सप्ताह में कंपनी को 16 नए पोर्टेंडब्ल्यू इंजन मिल जाएंगे, जिसके बाद वह अधिक विमानों का परिचालन कर सकेगी। एक अधिकारी ने यह जानकारी दी। गो फर्स्ट के कम से कम 25 विमान इस समय उड़ान नहीं भर रहे हैं।

# उपग्रह गेटवे के अलग लाइसेंस

ट्राई ने जारी की इनकी स्थापना और परिचालन के लिए लाइसेंसिंग रूपरेखा

**भा**रतीय दूरसंचार नियामक प्राधिकरण (ट्राई) ने सेटेलिट अर्थ स्टेशन गेटवे (एसईएसजी) के लिए अलग से देशव्यापी लाइसेंस बनाने की सिफारिश की है।

एसईएसजी की स्थापना और परिचालन के लिए लाइसेंसिंग रूपरेखा जारी करते हुए ट्राई ने मांगलवार को कहा कि भारतीय टेलीफ्रेक अधिनियम कीधारा 4 के तहत प्रस्तावित एसईएसजी लाइसेंस 10 साल के लिए नवीनीकरण के प्रावधान के साथ 20 साल की अवधि के लिए वैध हो सकता है।

उपग्रह गेटवे (जिसे टेलीपोर्ट या हब के रूप में भी जाना जाता है) एक ऐसा ग्रांड टेलीपोर्ट है जो उपग्रह से यहां उपग्रह को स्थानीय क्षेत्र वाले नेटवर्क के लिए डेटा प्रसारित करता है। इसमें पिंटाना और उपकरण लगे होते हैं, जो स्थलीय कनेक्टिविटी के लिए रेडियो फ्रीक्वेंसी (आरएफ) सिनल को इंटरनेट प्रोटोकॉल (आईपी) सिनल में बदल रखता है। भारत के कंपनी अधिनियम, 2013 के तहत पंजीकृत कंपनियां ही एसईएसजी लाइसेंस प्रदान करने के लिए आवधान करने की योजना है।

ट्राई ने कहा कि एसईएसजी
